# ORGANISATIONAL ELECTIONS 2014-2016 LIST OF FINAL NOMINATION

We publish herewith the final list of candidates contesting for the post of the Circle Executive Committee, Zonal & Regional Committees in SBI Officers' Association, (Bhubaneswar Circle) after taking into account the withdrawal of nominations on 27.12.2013.

2. As the number of contestants for all Committees other than Circle Executive Committee are equal to the number of posts/candidates to be elected, there will not be any polling for these committees. As such, Polling will be held only for electing Circle Executive Committee members. The candidates whose names appear in the list of the Zonal Committees and Regional Committees which was displayed in the Notice Board are therefore declared elected and the list would be advised through a separate circular. The name of the contesting candidates for the Circle Committee will appear in the ballot paper in the same order as they appear in the final list, displayed below in alphabetical order.

3. Further, Polling will be held in all the notified centres (as advised vide the Annexure to our Circular No.EC/01/2013 dated 12.12.2013) for electing the candidates for Circle Executive Committee only. The venue at various polling centres and detailed instructions to the voters is enclosed hereto for guidance of member voters. We request all the members eligible voters to follow the instructions meticulously and exercise their franchise.

4. In any conflicting issue, the decision of the Chairman of the Election Committee is final and binding on the parties.

All the members are requested to exercise their franchise and co-operate in the smooth conduct of the election.

### ORGANISATIONAL ELECTIONS-2014-2016 INSTRUCTIONS TO VOTERS.

- 1. The voters shall carry their identification, i.e. identity card issued by the Bank or a certificate issued by the Branch Manager identifying him/her with his signature duly countersigned. In case the voter is unable to produce any one of the above identity proof he is to be identified by more than one polling agents present in the respective polling booth. These instructions will also be applicable to voters who have been transferred after the preparation of the Voters List. The voter should report at his/her identified polling centre as advised vide Circular No.EC/1/2013 dt.12.12.2013 for polling as per the scheduled time. No member will be permitted to cast his/her vote after the closure of the polling time.
- 2. The voter shall enter through "Entry" gate and leave the hall through "Exit" gate, if any such arrangement is made in the Polling Hall.
- 3. The voter shall lead to the Returning/Polling Officer in a queue in an orderly fashion. At any one time there will not be more than one person before the Returning/Polling Officer.
- 4. The voter will follow the instructions of the Polling Officer in completing the polling.
- 5. The voter will sign against his/her name in the voters list before collecting the ballot papers and sign the declaration form supplied by the Returning/Polling Officer.
- 6. There shall be one ballot paper for the post of Circle Executive Committee. There shall be 20 Boxes at the bottom of the ballot paper as under.

The voter shall carry the ballot paper to the enclosure indicated to him/her and exercise his/her franchise by writing the Serial Number of his/her choice candidate (appearing against their name) in the boxes provided at the bottom of the ballot paper. There will be 20 boxes and the voter shall mark only one number as detailed above in each box. The marking so made in each box should be clear and unambiguous. Voters shall not carry any other papers or books to the enclosure except the ballot paper given to them by the Returning/Polling Officer.

- 7. Any marking more than twenty number will result in invalidation of the respective ballot paper. However, marking lesser than twenty number will not invalidate the ballot paper.
- 8. The voter shall not scribble anything on the ballot paper other than marking his/her vote inside the boxes. Number written outside the boxes will also make the ballot invalid..
- 9. (a) If the voter signs his/her name or writes any word or makes any other mark on it by which the voter becomes recognizable; the ballot shall be treated as invalid.
  - (b) If the number of votes recorded on the Ballot Paper exceed twenty (20), the entire ballot will be invalid.
  - (c) If, two numbers are filled in a single box, both numbers will be treated as invalid.
  - (d) If the serial number appearing against the candidate is repeated in more than one box it will be counted as only one vote for the said candidate;
  - (e) Any over writing/cutting of Number inside the boxes will make the number in the box invalid..
- 10. After marking, the voter will fold the ballot paper in the same fashion as it was given to him/her and march to the ballot box placed before the Returning/Polling Officer and insert the ballot paper fully into the ballot box and leave the polling hall immediately.
- 11. The voter shall not take the ballot paper outside the polling venue. Every ballot paper shall be put only into the ballot box.
- 12. Voters shall not enter into any conversation with other voters inside the polling hall. Voters shall not argue with the Returning/Polling Officer or any other volunteers in the polling venue.
- 13.No voter shall indulge in any campaigning within the premises of the polling booth.
- 14. Voters shall maintain absolute peace, law and order and help smooth and orderly conduct of the polling.
- 15. The decision of the Polling Officer is final and binding on the voter. The voters shall strictly abide by the ruling of the Polling Officer.
- 16. All the members are hereby appealed that they should attend the polling without fail and exercise their franchise. Elaborate arrangements have been made for early and expeditious polling at every station. Waiting period at each polling station will be minimal, if members present themselves within the stipulated time and avoid last minute rush.
- 17. Members transferred after 16th November 2013 from one branch/office to another covered within the same polling centre will be allowed to exercise their franchise on production of a letter from the Branch Manager advising the detail of transfer. If the change of place is already reflected in the voters list, letter from the Branch Manager may be ignored and the voter will be allowed to vote in the normal course.
- 18. The officers on deputation to Utkal Gramya Bank will be allowed to caste their vote in the respective polling centre where they are posted on production of a certificate of their posting by the Chairman, Utkal Gramya Bank.
- 19. In case of transfers between offices under different polling centres not reflected in the voters list, the following procedure will be followed:
  - (a) The member should produce a letter from the Branch Manager advising the details of transfer.
  - (b) The voter will cast votes pertaining to the polling centre as per present place of posting.

(c) Such votes after secret marking will be put in a separate sealed cover by the voter himself and be handed over to the Returning/Polling Officer.

(d) Name of the voter, his previous branch and the present branch should be distinctly marked on the face of the cover.

(e) The Polling Officer will receive the cover, make an entry in the voters list and prepare a separate list of such covers received. He will deliver the covers intact to the Chairman along with the list and the letters received from the Branch Manager.

(f) The Chairman will verify with master voters list and if satisfied with the claim of the voter, the vote will be accounted for counting.

(g) Any request of a voter to cast his/her vote at a centre other than where it is recorded in the Voters List can be entertained on medical ground and/or on official deputation. However, such cases will only be permitted by the polling officer on receiving such requests from the voter along with valid proof. In such cases, the procedure as mentioned above for transferred officers is also to be followed..

(h) Those voters who have been permitted to keep their families at a centre other than their place of posting, may be permitted to cast their votes at a centre nearest tot he place where their family reside, provided they apply for the same to the Chairman, Election Committee, to reach him on or before 10th January 2014.

(i) Voters desirous to change centre for any other acceptable reasons other than the above, may apply to the Chairman, Election Committee latest by 10th January 2014 and may exercise their franchise at the other centre subject to approval by Election Committee.

(ii) All requests for change of polling centre/venue must be in the prescribed format enclosed to this circular. The voters permitted by the Chairman, Eletion Committee to cast their votes at the other centre would be intimated through e-mail/sms and the list of such voters will be made available to the Polling Officer.
